I am responding to your letter of August 5, 2009 to Adjudicator Colin Bhattacharjee, who is currently away from the office.

In your letter, you state that you are "somewhat unfamiliar with the process of having issued an order and then resuming and inquiry." Please note that in Order Provision 3 of Order MO-2416, Adjudicator Bhattacharjee expressly stated as follows:

I remain seized of any compliance issues that may arise from this order and any new appeal that the appellant may file with respect to the access decision that the County is required to issue under Order Provision 2.

Your letter asks for an extension of the August 12, 2009 deadline for a response to Adjudicator Bhattacharjee's letter of July 28, 2009 to the County of Simcoe (the County). You state that it is "too late" for the matter to be placed before Council on August 25, and would have to wait until the September 22 meeting. You request an extension until a further 10 days following that meeting, that is, until October 2, 2009.

Your request for an extension is denied.

Order MO-2416 was issued on May 13, 2009. As you will note from Order Provision 2, once the County obtains the records from Jagger Hims, it must make an access decision under the



Municipal Freedom of Information and Protection of Privacy Act. Your extension request would have the effect of delaying the County's comments on how it intends to obtain the record from Jagger Hims until a date nearly five months after the order was issued. This is unacceptable.

Given the public attention that the proposed landfill at Site 41 has generated, this office regards the issue of compliance with Order MO-2416 as an urgent priority. We trust the County of Simcoe also regards it as urgent.

Please ensure that Adjudicator Bhattacharjee receives the County's response to his letter of July 28, 2009 no later than August 12, 2009.
